PART 1: CONSENT TO ALCOHOL/DRUG TEST

I understand that Party Plus Rentals enforces the following rule and I agree, if employed by Party Plus Rentals, to abide by this rule as well as other Company rules:

Alcoholic Beverages and Drugs

An Employee who reports to work in a condition unfit to work and under the influence of alcohol or drugs or who becomes unfit to work during working hours after taking alcohol or drugs or who is engaged in the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance or alcoholic beverage on Company property, including the parking lots, or on Company time, is subject to immediate discharge.

In the event I am offered employment with Party Plus Rentals I hereby voluntarily authorize any doctor, his/her employees or agents, together with any clinic, hospital or laboratory or other medical facility, to perform appropriate tests or examinations on my body fluid samples (for example, urinalysis and blood chemistry) for drugs and/or alcohol as part of a pre-employment physical examination. In the event I accept employment with Party Plus Rentals, I understand and voluntarily consent to the fact that drug and alcohol testing may be performed whenever a question arises concerning my performance on the job or my behavior on the Company's premises.

I further give my permission to such doctor, his employees or agents, clinic, hospital or laboratory or other medical facility, to release the results of these tests to Party Plus Rentals, its Medical Director or their authorized representatives I agree to release and hold harmless Party Plus Rentals, the examining physician and the laboratory, as well as each of their officers, agents and employees from any liability based upon the request for, administration of, and use of the results of any physical examination, including a substance abuse test.

This authorization, consent and release is of a continuing nature and shall continue from this date throughout any employment with Party Plus Rentals.
