INVOICING: All invoices and statements will be emailed or faxed. All payments should be sent to the Cockeysville address.

TERMS OF SALE: All charges are due in full 30 days from date of purchase or upon rendering of monthly statement. On balances more than 30 days old, it is agreed that a Finance Charge of 18% annual rate (or 1 ½% per month) will be charged. Finance charges are calculated using the average daily balance.

UNAUTHORIZED CHARGES: Applicant agrees to pay all charges made by any of Applicant's employees. Any claim for unauthorized charges must be made as soon as Company has notice of the charge and such claim must be submitted in writing within three (3) days of receipt of invoice.

ACCELERATION: If any payments to Party Plus Rentals are overdue, if Buyer fails to perform any obligation under this Credit Agreement other than the payment of monies, if Party Plus Rentals discovers that any statement in the Credit Agreement is untrue, or Party Plus discovers information that gives it reason to believe that Buyer will be unable to perform, Buyer shall be in default under this Agreement and Party Plus shall be entitled to immediate payment of all outstanding charges without prior demand or notice, without regard to any prior waiver or forbearance.

APPLICABLE LAW: This Credit Agreement shall be governed by the laws of the State of Maryland.

ATTORNEY'S FEES: Should the services of an attorney or collection agency be required to enforce any part of this credit agreement, or for the collection of a delinquent account from the signed Customer or Guarantor, it is agreed that the Debtor will pay reasonable costs of collection including reasonable attorney fees.

AUTHORIZATION: Party Plus Rentals is authorized to investigate the listed credit references and any other sources of credit information on the signed customer.
